Sales and Use Tax Structure in Washington

The Washington Supreme Court recently held in *Antio v. Washington State Department of Revenue* that the business and occupation tax deduction for investment income is limited to income earned through investments incidental to the main purpose of the taxpayer's business, even if the business is not a banking, lending, or security business. The Legislature provided additional clarity regarding the use of the deduction in Engrossed Substitute House Bill 2081 (2025). The Committee will receive an update on the implementation of this clarification as well as the expanded voluntary compliance program from the Department of Revenue. (One work session)

Working Families Tax Credit

The Committee will receive an update on the implementation and utilization of the Working Families Tax Credit program from the Department of Revenue. (One work session)

Economic and Revenue Forecast

LABOR & WORKPLACE STANDARDS COMMITTEE WORKPLAN

Report from the Underground Economy in the Washington State Construction Industry Task Force

In the 2024 Operating Budget the Legislature established the Underground Economy in the Washington State Construction Industry Task Force (Task Force). The Task Force is directed to study the nature and scope of the underground economy in the construction industry, recommend policy changes, if any, and determine whether greater cohesion and transparency among state agencies are needed. The Task Force must submit a final report to the Legislature by June 30, 2025. The Committee will hear a briefing on the final report. (One work session)

Report from the Wage Recovery Work Group

Substitute House Bill 2097 (2024) directed the Department of Labor and Industries to convene the Wage Recovery Work Group (Work Group) to develop and recommend strategies for helping employees recover unpaid wages and be made whole as quickly and fully as possible. The Work Group must submit a final report with recommendations to the Legislature by December 1, 2025. The Committee will hear a briefing on the final report. (One work session)

Overview of the Washington State Apprenticeship and Training Council (WSATC)

The Department of Labor and Industries (Department) is designated by the U.S. Department of Labor to approve and register apprenticeship programs. For this purpose, state law directs the Department to appoint a regulatory apprenticeship council, referred to as the Washington State Apprenticeship and Training Council (Council), to approve apprenticeship programs and establish apprenticeship standards. The Committee will receive an overview of the Council's structure, operations, and procedures, including the Council's approval process for new apprenticeship programs and standards. (One work session)

Update from the Department of Labor and Industries

The Department of Labor and Industries will update the Committee on emerging issues affecting agency practices and upcoming legislation, which may include an overview of workers' compensation taxes, benefits, and pensions, workplace injury data, changes in wage and hour requirements and enforcement, and agency request legislation. (One work session)

Update from the Employment Security Department

The Employment Security Department will update the Committee on emerging issues affecting agency practices and upcoming legislation, which may include an overview of rate setting and solvency issues in the Paid Family and Medical Leave Program, regulatory reform in the unemployment insurance system, and agency request legislation. (One work session)

Apprenticeships

The Committee will evaluate barriers to apprenticeships, such as the approval process for new apprenticeship programs, access to quality education and training programs in underserved communities, financial constraints, lack of mentorship and networking opportunities, cultural and language barriers, flawed and discriminatory hiring practices, and transferability of credits and degrees. The Committee will also explore opportunities to strengthen and scale apprenticeship models across diverse industries, ensuring they are inclusive, accessible, and responsive to both employer needs and worker aspirations. (One work session)

Nontraditional Students

The Committee will explore how institutions of higher education are serving nontraditional students, such as adults returning to higher education, and ways to improve and expand pathways for these individuals. This includes examining flexible learning options and programs, workforce-aligned credentials, and support services that address the unique needs of working adults, caregivers, and part-time learners. The goal is to explore ways to ensure that higher education systems are accessible, responsive, and equitable for a diverse and evolving student population. (One work session)

Workforce Development

The Committee will examine how workforce development programs are working to bridge the skills gap for both employers and job seekers. This includes evaluating the effectiveness of training and reskilling initiatives, the alignment of programs with current and emerging labor market demands, and partnerships between education providers, employers, and community organizations. The Committee aims to identify strategies that support a dynamic, inclusive, and future-ready workforce. (One work session)

Youth Mental Health

The Committee will receive briefings from institutions of higher education on best practices for supporting student mental health challenges, such as improving access to resources to help mitigate the negative impact mental health issues have on retention, academic performance, completion rates, and overall student happiness and wellbeing. The Committee will also explore how institutions are integrating mental health into campus culture, training faculty and staff to recognize signs of distress, and leveraging technology and peer support models to reach more students. (One work session)

Impact of Artificial Intelligence in Higher Education

The Committee will explore how the increasing prevalence of artificial intelligence (AI) in higher education is impacting ethical, social, and educational dynamics within the sector, including its influence on teaching, learning, institutional administration, and academic integrity. The Committee aims to better understand the risks and opportunities of AI integration to help inform policy development. (One work session)

High School and Beyond Platform and Transition from K-12 to Higher Education

The Committee will receive a briefing from the Office of Superintendent of Public Instruction (OSPI) on its implementation of the statewide universal online High School and Beyond Plan (HSBP) platform, as required under Engrossed Second Substitute Senate Bill 5243 (2023). The briefing will focus on how the HSBP platform provides students across the state with equitable access to the same career and college exploration opportunities, and on other ways OSPI ensures students have access to guidance about options after graduation such as its Career Guidance Washington Lessons. (One work session)

TRANSPORTATION COMMITTEE WORKPLAN

Washington State Ferries - Vessel Procurement and Other Capital Updates

The Committee will monitor and receive updates on the capital activities of the Washington State Ferry (WSF) system. The primary focus will be the ferry electrification program, including the procurement of new hybrid electric vessels, the status of terminal electrification efforts, and the conversion of the Jumbo Mark II vessels. The updates will also cover other significant capital undertakings including the Fauntleroy terminal and the Jumbo Mark II midlife vessel rebuilds.

The Committee will also monitor and evaluate the WSF workforce development investments as the WSF returns to full domestic service. (One work session)

Highway Project Delivery Update

The Committee will receive an update from the Washington State Department of Transportation (WSDOT) on the delivery of highway improvement and preservation projects. Key topics will include: recent project cost trends, based on bids and updated cost estimate validation process (CEVP) results submitted since the 2025 Legislative Session; the current procurement environment; and WSDOT's contracting strategies for managing costs and risks. WSDOT will also provide an overview of its capital project cost estimating policies, risk assessments, and considerations for the potential development of a highway capital projects risk pool. (One work session)
